



WILLIAMSON COUNTY SENIOR 4-H AWARDS GUIDELINES

These guidelines contain information about applying for the County 4-H Gold Star Awards, and the “I Dare You” Awards.

GOLD STAR AWARD - The Gold Star Award is the highest County 4-H achievement award. The following criteria are based upon the state guidelines as stated in the current Texas 4-H Clover. Any 4-H member not meeting these criteria will not be considered for the award.

Criteria for Selection:

1. The member must have at least completed, or be completing their 9th grade school year at the time of application.
2. The 4-H member must have completed at least 3 years in 4-H including the current year.
3. The Gold Star Award will be presented to the most deserving young person without regard to gender.
4. The 4-H member must submit a 4-H Record Book in the year he or she is to be considered for the Gold Star Award.
5. **Projects and Activities:** During his or her years in 4-H, member must have:
 - A. Completed projects in three different project areas including submission of appropriate record forms.
 - B. Participated in one or more activities in at least three of the following areas:
 - ✦ Method Demonstration/4-H Presentations
 - ✦ Contests
 - ✦ Project Exhibits
 - ✦ Camps
 - ✦ Leadership Lab or Surge (Leadership Camp)
 - ✦ Citizenship Activities
 - ✦ Public Relations (for example, demonstrations, speeches, poster displays, club exhibits, project shows, radio, TV, newspapers, special projects)
 - ✦ Other (may include exchange programs, fund raising, State and National 4-H Congress, etc.)

Note: It is not expected that the above requirements for projects and activities all be complete in the current year. They may have been accomplished over the entire period of time the 4-H'ers has been in the 4-H program.

6. **Leadership Skills:** During his or her years in 4-H, the member must have exhibited leadership skill sin one or more of the following areas:
 - A. Must have served as an officer or committee chairman at some level of 4-H organization (club, county, district, state).

- B. Must have served as junior or teen leader in an activity or project with or under the supervision of an adult volunteer leader.
- 7. Community Service: The 4-Her must have participated in one or more community service activity, either individual, group, or club-type projects.
- 8. Judging Process:
 - A. Complete and submit a Senior 4-H Awards Application.
 - B. Complete a personal interview with a panel of 4-H Awards Judges.

DANFORTH “I DARE YOU” AWARD - The Danforth Award is awarded each year to Senior 4-H members in recognition of excellence of character and well balanced personal development, as well as demonstrated leadership.

- ☐ Same requirements as for Gold Star Award.
- ☐ Must not have received “I Dare You” Award from any other source (school, community group, etc.)

JUDGING PROCEDURES

Judging for Senior Awards consists of:

- ☐ a check of award eligibility and required application materials
- ☐ judging of the awards application
- ☐ an interview with a panel of judges
- ☐ review of 4-H record book and achievements
