



## WILLIAMSON COUNTY SENIOR 4-H AWARDS GUIDELINES

These guidelines contain information about applying for the <u>County 4-H Gold Star Awards</u>, and the "I Dare You" Awards.

<u>GOLD STAR AWARD</u> - The Gold Star Award is the highest County 4-H achievement award. The following criteria are based upon the state guidelines as stated in the current Texas 4-H Clover. Any 4-H member not meeting these criteria will not be considered for the award.

## Criteria for Selection:

- 1. The member must have at least completed, or be completing their 9th grade school year at the time of application.
- 2. The 4-H member must have completed at least <u>3 years in 4-H</u> including the current year.
- 3. The Gold Star Award will be presented to the most deserving young person without regard to gender.
- 4. The 4-H member must submit a <u>4-H Record Book</u> in the year he or she is to be considered for the Gold Star Award.
- 5. <u>Projects and Activities:</u> During his or her years in 4-H, member must have:
  - A. Completed projects in <u>three</u> different project areas including submission of appropriate record forms.
  - B. Participated in one or more activities in at least <u>three</u> of the following areas:
    - ♦ Method Demonstration/4-H Presentations
    - **♦** Contests
    - ♦ Project Exhibits
    - ♦ Camps
    - ★ Leadership Lab or Surge (Leadership Camp)
    - ♦ Citizenship Activities
    - ◆ Public Relations (for example, demonstrations, speeches, poster displays, club exhibits, project shows, radio, TV, newspapers, special projects)
    - ♦ Other (may include exchange programs, fund raising, State and National 4-H Congress, etc.)

Note: It is not expected that the above requirements for projects and activities all be complete in the current year. They may have been accomplished over the entire period of time the 4-H'ers has been in the 4-H program.

- 6. <u>Leadership Skills:</u> During his or her years in 4-H, the member must have exhibited leadership skill sin one or more of the following areas:
  - A. Must have served as an officer or committee chairman at some level of 4-H organization (club, county, district, state).

- B. Must have served as junior or teen leader in an activity or project with or under the supervision of an adult volunteer leader.
- 7. <u>Community Service:</u> The 4-Her must have participated in one or more community service activity, either individual, group, or club-type projects.
- 8. <u>Judging Process:</u>
  - A. Complete and submit a Senior 4-H Awards Application.
  - B. Complete a personal interview with a panel of 4-H Awards Judges.

**DANFORTH "I DARE YOU" AWARD -** The Danforth Award is awarded each year to Senior 4-H members in recognition of excellence of character and well balanced personal development, as well as demonstrated leadership.

Same requirements as for Gold Star Award.
Must not have received "I Dare You" Award from any other source (school
community group, etc.)

## **JUDGING PROCEDURES**

Judging for Senior Awards consists of:

a check of award eligibility and required application materials
judging of the awards application
an interview with a panel of judges
review of 4-H record book and achievements
